## Definitions

**Number of Successful Transactions** - includes any applications completed or submitted to partners through OneStop. In the case of CRA, this is for Linked applications only. For WorkSafeBC, this only includes transactions that have returned to OneStop after completion and therefore may not represent the total number of completed registrations at iReg. One Municipal Business Licence transaction may include business licences for multiple municipalities.

**% of Total Transactions** - calculates the number of successful transactions by registration type and divides it by the total of all successful transactions.

**Successful Sessions** - any session with one or more successful transaction.

**Average # of Successful Transactions per Customer** - calculates the number of successful transactions divided by the number of successful sessions.
